




Merritt Welch '29 Passes Away

Brother Merritt L. Welch '29 of Minot and Sun City, AZ passed away on July 25, 1987 in Minot. His illness was short, and death unexpected.

We have lost a fraternal great. A year ago at Homecoming '86, he was honored by the Chapter with a Merritt Welch Appreciation 'Day which gave us a fine opportunity to show our appreciation for his 60 years of dedication, loyalty and service. At the affair, the National Fraternity presented him with the Distinguished Service Chapter Award, and Merritt became one of less than 200 Delts so honored since our founding in 1858. The award read:

"Longtime chapter advisor of Delta Xi Chapter at the University of North Dakota and visionary house corporation president, this insurance executive and civic leader freely devoted his time and talents to the betterment of the Fraternity. It was his tenancious leadership, and business acumen that enabled Delta Xi to enjoy financial security for over fifty years. His loyal service to the general Fraternity in many capacities has, indeed, been an inspiration to generations of Delts." Presented October 6, 1986.

The Educational Foundation established the Welch Chairman Award endowment several years ago to honor Merritt, and contributions to that endowment now produce interest income of \$200 each year for outstanding chairman who go above what is expected of them and excel with their committee. It is a fitting tribute for his many years of service, dedication and loyalty for the ideals of the Fraternity. Each year as we present the award, we will remember his fine work and perpetuate his memory.

Merritt graduated in 1929 with a B.A. degree in Chemistry. He was employed by Implement Dealers Mutual Insurance Company in Grand Forks where he rose to President and Chairman of the Board before retiring in 1974. He served as a fund (Merritt Welch continued on page 3)

George Allen Appreciation Day

All members are encouraged to participate in a George Allen Appreciation Day on Saturday, October 3, during UND Homecoming '87. The Appreciation Banquet will be held at the American Legion Club near the Sorlie Bridge in East Grand Forks, MN. It starts with a 5:15 p.m. social and dinner will be served at 6:00. The chapter will have their annual Pledge Princess Ball following the activities and alumni and their spouses are invited to attend, or also participate in the All-Alumni Party at the Civic Auditorium.

The Fraternity has honored Brother Allen '36 before and recognized him for his many contributions to our welfare. He has received the Fraternity's highest recognition and most prestigious award, the Distinguished Service Chapter Award in February, 1981. This time however, the alumni and undergraduate members are asked to participate and offer their appreciation in person. We will have a roving microphone at the banquet and all who would like to make a personal comment to George will be invited to do so.

It has been over half a century since George first dedicated himself to the Fraternity and its members. Our records indicate that he may have returned to the chapter every single year since his graduation from Law School in 1936 with the exception of the years of WW II. That is a show of dedication and loyalty that has earned him the title of "Mr. Delt", and also means that every pledge and inititated member has had the opportunity to have felt his warm hand of fraternal brotherhood. He is also the leader that has helped our chapter realize many goals, meet major milestones, and make national fraternity history with our Educational Foundation and other programs. All of us have benefited in some way from his generosity, encouragement and leadership.

George always underestimates his presence and continued support, saying "I am simply returning a favor, and showing appreciation for what the Fraternity has meant to me." It is difficult to imagine, however, Delta Xi Chapter without his presence. When situations were tough, it was George who still had hope, saw the potential, and inspired us to keep reaching for our goal. He allowed our members to reach their potential through encouragement and support. Always he made us feel good for our participation. His smile, his spirit, his demeanor has inspired many an undergraduate and alumni member, reminding us that membership is forever.

After Law School, Brother Allen went to work for GAB Business Services Inc., a worldwide insurance adjusting firm. His travels were extensive, and he had a most distinguished record of accomplishment until his retirement in 1978. As a senior adjuster for the company, George faced some tough assignments: he was on the scene in the aftermath of the mid-'60's race riots in Watts of Los Angeles and in Cleveland, and he helped assess the damages after the Indian occupation in Wounded Knee, South Dakota in the early 1970's — not far from his summer home in the Black Hills.

George and his wife Pat — a Gamma Phi of 1934 have two children, son Bob in Chicago and daughter Judy in Denver. They plan to join us for the George Allen Appreciation Day, and we hope you do too. Brother Welch served on a number of national insurance company boards from that affilation.

Four Accountants Buying Local Practice

Four Fargo certified public accountants are purchasing the local accounting practice of McGladrey Hendrickson and Pullen effective Sept. 1.

The new organization will be incorporated as Haugen, Wright, Johnson and Mohagen Ltd. and will continue in its present offices at 10 Broadway. A staff of 13 other full-time employees will be retained.

Under a networking agreement with the McGladrey firm, the local company will continue to utilize some of its resources, including educational courses and consultants.

The partners in the new company are Donald Haugen, Wilbur Wright, Craig Johnson and Rodger Mohagen.

Haugen, Wright and Johnson are partners in the Fargo office of McGladrey Hendrickson and Pullen while Mohagen most recently worked for Eide Helmeke and Co. in Fargo.

Haugen, who is general service partner in charge of McGladrey's Fargo operation, joined the firm's predecessor, Broeker Hendrickson and Co., in 1970. He became a partner in 1979.

Haugen is a graduate of Central High School in Fargo and of Moorhead State University. He and his wife, Glenda, have two children and live in Fargo.

Wright is a native of Antler, N.D., and a 1965 graduate of the University of North Dakota, Grand Forks. He has worked as a general accountant in Minneapolis and Kansas City, Mo.

Wright joined Broeker Hendrickson and Co. in 1973 and worked in St. Paul and Worthington in Minnesota before transferring to Fargo in 1981. He and his wife, Carolyn, have two children and live in Fargo.

Johnson is a native of Sidney, Mont., and a 1974 graduate of Concordia College.

He joined the local accounting practice of James McMerty Ltd. in 1975. That firm eventually merged into the McGladrey practice.
