

## FROM DELTA Xi

## \$108,000 Endowment Fund Drive Hits Half-Way

In just five months since the \$108,000 endowment drive was launched to pay-off the mortgage with the National Fraternity, \$55,000 has been raised marking the half-way point. Fund drive chairmen Neil Fleming '65 and Jim Lewis '55 are very pleased with the progress.

Over sixty alumni have participated so far in the endowment drive with an average gift of over \$900. All alumni are being asked to contribute at least \$250 over a two-year period, and with 100% participation, the mortgage would be purchased with the endowment so future interest payments (in excess of \$90,000) will go towards scholarships, achievement awards and leadership programs. There are about 490 alumni on the mailing list.

The Mortgage with the National Fraternity is due in May, 1989. The original mortgage was taken out in 1979, and had a ten year balloon on it. In ten years over \$76,000 in interest payments have been made on a \$120,000 loan at  $7\frac{1}{2}$ %. Only \$11,200 in principal has been paid. Another \$90,000 will be paid before the loan is retired prompting the fund drive. The Board of Directors would rather invest the interest payments in scholarships to deserving members than to pay off a loan.

Alumni are encouraged to participate with a pledge and contribution by May, 1989 so the Board of Directors will know how to negotiate the loan and under what timeline. Bruce Gjovig '74 noted that it has been ten years since many alumni have participated in the fund drive, not having contributed since the new chapter house was built. He hopes that alumni can be interested in participating again after this lapse of time.

### Tribute to Albert Hallenberg, D.D.S. '00

Dr. Albert Hallenberg worked for many years to assist Beta Chi Fraternity in securing its Delt Chapter. The members of Beta Chi made a careful selection in choosing Delt, and after fifteen years as a local convinced Delta Tau Delta to accept Delta Xi chapter on November 22, 1935. He was chairman of the Installation Committee.

Brother Ted Kellogg '30 was the driving force, and made the formal presentation at the Karneas and Regional Conferences, and it was Dr. Hallenberg who served as our Delt sponsor. He was untiring and persistent in supporting our cause of affiliating with Delta Tau Delta, and Delta Xi is just one of four chapters accepted into the Fraternity during the Depression. The National Fraternity was more interested in keeping existing chapters than expending energy on new chapters. Albert Hallenberg '00 was a member of Beta Eta at Minnesota and Omega Chapter at Pennsylvania and his interest in Delt was more than just casual. His son, Childs, was an ATO at NDSU, but spent 1935-1936 with Delta Xi as our social chairman. Dr. Hallenberg wanted his son "to have some Delt exposure". A half-brother of Dr. Hallenberg's, Edward X. Hallenberg, was chapter president at the time of installation.

Dr. Hallenberg was one of the leading dentists and civic leaders in the upper midwest, active throughout his life in promoting dental society work at the local, state and national level. He attended the North Dakota Agricultural College (now NDSU), and the University of Minnesota, and graduated in 1900 from the University of Pennsylvania School of Dentistry. In 1918 he did post-graduate work at the Royal College of Surgery in Toronto, Canada.

He practiced dentistry in Fargo througout his life, and was honored many times. He was chairman for North Dakota in 1904 at the International Dental Congress. In 1905, he founded the Fargo District **Dental Society** and the next year the North Dakota State Dental Association. He was vicepresident of the American Dental Association, a fellow of the American College of Dentists, president



of the North Dakota State Dental Association.

Brother Hallenberg was born at St. Paul on October 1, 1879, and moved to Fargo as a youth with his family. In 1903, he married Pearl Childs of Chicago and they had two children, Childs and Charlotte. He passed away on November 17, 1940 at age sixty-one.

In a tribute, Brother Hallenberg was called "a sterling gentleman with a gracious smile, his inimitable personality, his cheerful disposition have brought to his side scores of friends and brothers." We pay tribute to a fine sponsor that enabled us to enjoy the benefits of Delta Tau Delta today.


