Ferguson Stewart Endowment Established

Sandra Stewart Bracken of Littleton, Colorado established a \$15,000 endowment in honor and memory of her father, Ferguson C. Stewart '38. The interest from the endowment will be used to continue providing grants to financially needy Delts to help them stay enrolled in UND and involved in the Fraternity. Brother Stewart began helping needy students in 1981 and continued to provide grants until his death in June of 1989. He provided many thousands of dollars in support of this program, helping in excess of twenty members over eight years. Approximately \$1,200 will be available annually from this new endowment to help several Delts.

With his gifts, Stew made his intentions known. On January 7, 1987 he wrote, "I like to help those young guys having a tough time." On December 31, 1984, he requested, "Use this to help deserving brothers to stay

in school and not drop out." On November 5, 1981, he asked "I specifically request the enclosed to be used to assist some struggling and deserving young men. I don't care if he has high marks." Stew very much wanted young people to get a college education, and was eager to lend a helping hand to those in need. He knew that a modest investment makes a significant difference to help keep a member enrolled in school and active in the Fraternity.

Recalling his own days as a student in the 1930s, Brother Stewart understood that small amounts of money could make ends meet thereby keeping a student enrolled, pursuing an education. Often if a student dropped out, they did not go back to school. Since 1980, tuition has tripled and other college costs have increased dramatically, while a student's wages and financial aid have remained the same. This has created very tight budgets. Alumni support means more now than ever before to make an education available by providing much needed financial assistance, and rewarding effort and excellence.

Brother Stewart retired as a Lt. Colonel in 1961 after a military career in the US Army. Afterwards, he was Director of Security at Packard Bell and then Teledyne for ten years, and then became a security consultant with many companies which needed DoD clearances and security inspections. Stew's wife, Chris Dalstad, passed away in January, 1985.

The men of Delta Tau Delta appreciate this generous endowment very much.

CHAPTER RECOGNIZED!!

This past year the chapter has been honored with many awards. In February at the Northern Division Conference, the chapter received three awards. The first of which was given by the Northern Division for the Most Improved Chapter in the Division. The next two awards the chapter earned were presented by the Arch Chapter for national accomplishment. The initial award was given for chapter Rush Improvement. This was quite an honor because the voting members are our own peers, fellow fraternities and sororities. Robert G. Williams, also was honored at the UND Banquet. Robert received the Most Valuable Member award, given by the Inter Fraternity Council.

PLEDGE DELT AGAIN

Gifts to the Delta Tau Delta Educational Foundation can be made in various ways such as cash, deferred or testamentary gifts. With the 501(c)3 status from the IRS, contributions to the Educational Foundation are tax deductible, and favorable capital gains treatment can be realized with gifts of appreciated property such as stocks.

Direct Contributions

A cash contribution is the most common gift received by our Educational Foundation, and some sixty plus alumni make annual contributions for general and specific support. Several named endowment accounts have been established, and sizeable endowments have been created through annual gifts. Interest from these endowments are used as the donor requested for academic scholarships, achievement awards, or other programs designated by the donor.

From a tax viewpoint, a gift of appreciated property (securities, stock, real estate) may be more attractive than cash. If property has grown substantially in value, capital gains tax must be paid on any gain realized when sold. But if the property was contributed to the Educational Foundation, no capital gains tax is paid on the "paper" profit and a charitable contribution is received on the full market value of the property.

Deferred Giving

Deferred gifts are arrangements whereby the donor and spouse can continue to receive income or continue to use their property. Examples are gift annuities or unitrusts. By making an irrevocable contribution, to go into effect later, the donor gains an immediate contribution deduction and often increases annual income, and defers or avoids capital gains tax.

Testamentary Gifts

Several alumni have indicated that they have included the Educational Foundation as a beneficiary of their

Delt Cadet Pushes First Amendment Rights

Reed Endersbe '93, a UND sophomore wore his ROTC military fatigues to his Introduction to the Study of Women class on January 31. The instructor, Sandra Parsons, asked him not to wear them again because "the uniform symbolizes the power and violence in the world that we look at every week in class, and the dress could disrupt the class."

Brother Endersbe complained, saying he should be allowed to wear the uniform to class as UND has no dress code, and ROTC is a recognized academic program of the University. He added that there is a right to freedom of expression under the First Amendment which allows him to wear whatever he wishes. "I wasn't trying to make a political issue in the class. It isn't a political class or a peace studies class," Reed said to the press. Reed wore the uniform because he had a ROTC class meeting immediately after the course.

Bernard O'Kelly, Dean of the University's College of Arts and Sciences decided Endersbe should be allowed to wear the uniform. "Since this is a possible question of symbolic speech, the student's First Amendment rights were at stake," he said. However, no disciplinary action was taken against Parsons. Reed subsequently dropped the course because of the tension with the instructor.

While an undergraduate, he served as Scholarship Chairman and as Vice President of the chapter. As a student, he was an assistant to Louis Geiger while writing the book *University of the Northern Plains*. It was published for UND's 75th year celebration.

Bruce retired from the Social Security Administration in 1974 as Chief of Budget and Finance Office, Bureau of Retirement and Severance Insurance. His office was in Baltimore, Maryland. C. A. "Scotty" Cranna and his wife Anna will be moving to Grand Forks shortly, after spending 51 years in Devils Lake.

Both will be 83 years old in June.

Cranna has a longtime background in business affairs and civic contributions. The Devils Lake Area Chamber of Commerce recognized his efforts with a plaque honoring his years as a chamber ambassador Thursday.

"Scotty has sure been faithful with the ambassadors and a lot of other things," said Chamber Executive Joanne Rodenbiker. "He has been faithful even when nobody else showed up."

"And he has been quite a figure in a lot of other areas of our community too. The Boy Scouts presented him with their Silver Beaver Award.

"He undoubtedly will be missed by our community."

Scotty and Anna will be moving to Parkwood Retirement Place in Grand Forks. The couple will be

taking with them a lifetime of Devils Lake memories.

Cranna and Art Stromquist were instrumental in founding Ramsey Motors, which was located in the present Firestone location.

He sold his portion of the business to Paul Stenhjem in 1960, took over Schultz Bar for a year, and later sold and appraised real estate with Earl Pederson.

"It's going to be hard to leave Devils Lake after all these years," Scotty admitted. "But my wife was beginning to have trouble keeping the house up, and I just hated the idea of going from a house to an apartment. We felt this was the right move for us."

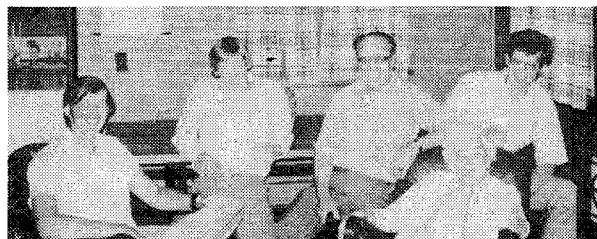
Wednesday night, the Lutheran Church Scotty and Anna have attended over the years bade them farewell too. Church members got their hands on some old Scottish songs that conjured up a lot of memories for the couple.

Scotty came to North Dakota in 1909 from Scotland, and landed in nearby Lakota when he was five months old.

"I remember my mother singing a lot of those old Scottish songs we were singing," Scotty smiled. "It brought back a lot of memories. We'll be leaving a lot of good friends here."

The photograph was taken June 4, 1972 at George Allen's '35 cabin near Mt. Rushmore (Keystone, South Dakota) in the Black Hills. As President of the Delta Xi House Corporation, Brother Allen was hosting a summer retreat with the chapter president, treasurer, scholarship chairman, and chapter advisor. At this meeting, George established the George Allen Most Improved Scholarships to recognize and reward the Deltas who make the most improvement in their grades. From this scholarship, and the Hallenberg Red Key Award established in 1938 recognizing the outstand-

ing pledge of the Fall semester, grew the Delta Tau Delta Educational Foundation founded in 1977, and approved by the IRS in 1978. Since the Educational Foundation was formed \$78,000 has been awarded to members in the form of scholarships and awards, over \$500,000 has been received in cash gifts, and another \$241,000 in pledge and deferred gifts.

Rush Report

WENDELL LOKKEN '32 died December 21, 1990 in Bowman, ND. He was 81 years old. Brother Lokken was born July 5, 1909 at Hettinger, where he was raised. He graduated from Hettinger High School in 1926 and attended the University of North Dakota where he joined Beta Chi Fraternity. He graduated from Mayville State College with a degree in education.

Wendell married Olive Magoon on December 7, 1934 at Hettinger, and they moved to Bowman in 1935 where he worked for the Bowman County Pioneer. He bought the Pioneer in the 1940s, and published it until his retirement in 1970. Wendell served as Mayor of Bowman, and served as Director of the Bowman County Fair Board and St. Luke's Tri-State Hospital Building Committee.

Mrs. Lokken passed away in 1973. Wendell is survived by one daughter, Sheala Erickson of Donnybrook, ND; one son, Craig Lokken of Jacksonville, FL; grandson, W. "We the undersigned men students of the University of North Dakota, in order to better develop the spirit of friendship now existing among us, to inculcate this spirit in the hearts of our associates, and to foster and further the ideals and activities of our University, do hereby petition the University Council for permission to organize and be known as the Beta Chi Fraternity of the University of North Dakota."

That petition to the University signed by our nine founders on December 16, 1920 established our Fraternity at the University of North Dakota. Formed in the bonds of friendship, those early Beta Chis worked hard to build a fraternal organization of highest quality, to attract the finest of men, and stressed scholarship. To quote Dr. Albert Hallenberg '00, "As time passed, the Beta Chi group was known as the strongest local fraternity on the University campus and proved this statement by its policy of pledging and initiating small and select groups each year."

Since our beginnings after World War I, over 780 Beta Chis and Delts have enjoyed fine fellowship, a meaningful out-of-classroom education, and an association with a Fraternity that is an international leader. As a chapter we pause to say "thank you" to all alumni who worked to pass on a fine tradition at the University of North Dakota. We look forward to passing the torch to future generations of Delts.

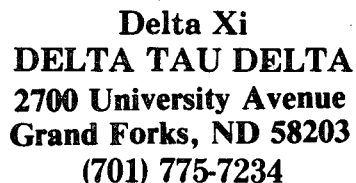
