AUSTRALIAN DIPLOMAT VISITS THE DELTS

At the Monday night dinner, November 19, Delta Xi Chapter had the pleasure of hosting Australian Diplomat, Norman Gomm. Counselor Gomm was visiting the University of North Dakota at the invitation of President Clifford, and he wished to visit with some university students. Delta Tau Delta was chosen because of their reputation as gentlemen, a well kept-up chapter house, and because several members had impressed administrators previously. We were proud to be chosen for this honor to represent UND students and the Greek system.

President Clifford, who is also serving as chancellor of the University System, has invited dignitaries to North Dakota in an effort to internationalize the campus and create business opportunities as we learn to function in a global economy. Three previous embassies had sent delegations to North Dakota - Germany, the Netherlands, and Finland. Diplomats are rarely invited to universities, and they are anxious to meet researchers and administrators at nationally ranked institutions.

This was Counselor Gomm's first visit to the state, and he spent most of his time at UND and NDSU. At UND he made special tours of the Energy and Environmental Research Center and the Center for Aerospace Sciences as Australia seeks an exchange of talent and technology in those areas. Australia is the third largest importer of North Dakota goods, behind Canada and Mexico, and ahead of Germany. North Dakota exported

nearly \$16 million worth of goods to Australia in 1989. Manufactured goods, such as farm equipment, make up the bulk of the exported goods.

Counselor Gomm was fascinated by the concept of fraternities. Greek letter organizations are only found in the United States and Canada, and he had not had an opportunity to visit a fraternity chapter before. He immediately commented on the benefit of fellowship and mutual gain, and was surprised at the emphasis on academics, community service, and leadership development. Chapter President Bob Williams '91 and Pledge Class President William Kehoe '93 were his official hosts and visited with him over dinner. Bruce Gjovig '74 of the Center for Innovation and Wes Christenson '64 (SAE), Director of Corporate and Foundation Relations at UND, accompanied Mr. Gomm to the chapter house.

During the fireside chat, Counselor Gomm made a few comments about his homeland, noting that it is nearly as large as the United States, but only inhabited with 17 million people. He suggested that should someone be interested in exporting to Asia, that Australia would be a great base of operations as the government is stable, and English law, language and business operations would be very similar. He noted that the blackbox used by airlines are an Australian invention, as are the microwave landing systems being installed in airports nationwide. He also noted that the Australian dollar is similar in value to the Canadian dollar, and educated and wealthy people have special status for immigration.

OVER 60 ATTEND AT HOMECOMING

Homecoming '90 was well attended by undergraduates, alumni and spouses. The Delt Banquet at the Ramada Inn was overflowing, and a large contingent was attending the Aviation Banquet on campus with a table up front for Delt Alumni that was introduced as undergrad Delts received several scholarships.

Chapter President Robert Williams served as master of ceremonies. The DTD Educational Foundation distributed scholarships and awards to deserving members. Delta Tau Delta Chapter Consultant, James T. Hise '89 (Gamma Chi - Kansas State), was our main speaker reviewing the strengths of our chapter, indicating it was among the strongest on campus and in the Northern Division. He congratulated the chapter on their leadership position in the entire Fraternity on Delts Talking About Alcohol Program, and the Educational Foundation. Hise ended his presentation with a message from the National Office to burn the mortgage with the National Office as it was paid in full in June, 1990. Signers of the mortgage, George Allen and Bruce Gjovig, were present for the ceremonial retirement of the mortgage, as was President of the Educational Foundation Neil Fleming and President of the House Corporation Joel Medd.

STEPHEN EIMAN '79 MUSIC SCHOLARSHIP ENDOWMENT ESTABLISHED

During Homecoming '90, an announcement was made by Bill Herauf '79 of Dickinson, North Dakota and John Dynes '80 of Casper, Wyoming of the establishment of the Stephen W. Eiman Music Scholarship Endowment within the Delta Tau Delta Educational Foundation. They wished to remember and honor "Rock" with a named scholarship endowment for musically talented members of the Fraternity. The scholarship will also provide recognition for a worthy Delt who is taking an active interest in music within the chapter.

Criteria for the Eiman Music Scholarship(s) will include enthusiasm for music, leadership for singing Fraternity songs, and participation in UND groups such as the concert choir, band or the Varsity Bards with whom Rock sang. Financial need may be taken into consideration for the award, especially if it may help keep a student enrolled in college. Initial contributions of \$5,000 have been received to date for the endowment. Further participation is encouraged.

Rock was well known and popular for his music talent both as a ragtime piano player and a gifted singer. His deep bass voice was a familiar sound in the house, in the Varsity Bards, or in the "Delta Tones", a Delt quartet who sang at the 50th chapter anniversary in 1985. Rock built a two-seat Pitts aerobatic airplane, and was well respected as a natural and professional pilot. He served as a DC-9 pilot for Northwest Airlines. Even in poor health, he crafted model aircraft to fly. Music and aviation were his life.

Twenty-three Dels and spouses were in attendance for the eulogy on Saturday night of Homecoming to remember and pay tribute to Brother Stephen Eiman '79 who passed away at age 34 on May 4, 1990. Also attending were Rock's parents from Lake Pocono Preserve, Pennsylvania, Dr. John and Daisy Eiman, and his brother from San Francisco, Jack Eiman. The family recalled memories and incidences from his youth, and Rock's difficulties during his final months. Each Delt and spouse recalled fond memories when Rock served as cook, treasurer, or vice president of the chapter and praised him for his many fine qualities and talents. Tears and laughter punctuated the memorable eulogy. It was a beautiful and meaningful evening, as a tribute was paid to an outstanding brother.

Dewing Addresses UND Alumni



Merlin Dewing '56 '58 was the keynote speaker for the UND President's Club dinner on October 18, speaking to several hundred financial benefactors to the University of North Dakota. This is the annual banquet hosted by the UND Foundation in appreciation of the support and investment made in UND.

Brother Dewing is Vice Chairman-Audit of KPMG Peat Marwick Main, a multi-national partnership of Certified Public Accountants with over 350 offices in 89 countries. He sits on their board of directors, and is chairman of the firm's Domestic and International Audit Practice Committee. Prior to his election as vice chairman, Merlin served as managing partner of Peat Marwick's office in Minneapolis. Merlin has worked with a number of FORTUNE 1000 companies including General Mills, Land O'Lakes, Peavey, IDS and Control Data. He is currently worldwide engagement partner of Pepsico.

Merlin has served as President of the UND Alumni Association during the Centennial celebration. In 1983 he was a recipient of the UND Sioux Award, the highest honor bestowed by the University for distinguished service and outstanding professional and civic achievements. In 1988 he received an honorary doctor of laws degree from the University of North Dakota for his advocacy of corporate social responsibility and of rigorous ethical standards in the public accounting profession. In 1985, Brother Dewing received the National Alumni Achievement Award from Delta Tau Delta, and now sits on the Steering Committee for the \$6 million endowment campaign.

Merlin and Barbara live in Darien, CT. They have three children.

Gehrke inducted into Athletic Hall of Fame



Maurice Gehrke Crosby, North Dakota, Maurice (pronounced "Morris") Gehrke was a member of the UND Football team as a freshman in 1931, and moved up to earn varsity letters in 1932, 1933, and 1934. Gehrke was an All-North Central selection as a guard. He was dubbed "Sunny-Jim" by Coach C.A. West for his pleasant personality and smile. Gehrke also lettered in boxing.

Brother Gehrke affiliated with Beta Chi, earned the Ruud Scholarship, and was a member of Blue Key. In 1935, he graduated from UND's School of Commerce. He served as service manager at Valley Motor of Grand Forks for three years, general auditor for the Jewel Team Company for three years. Maurice married Wilma Jean

Maurice Gehrke '35 was posthumously inducted into the UND Athletic Hall of Fame at ceremonies during Homecoming '90 on October 20.

A walk-on from Crosby, North

Schmaltz, a University of Indiana graduate and former student body president.

When World War II broke out, Gehrke just started working for General Electric. He resigned to join the Army and was assigned to the Quartermaster Corps in Jefferson, IN. He reached the rank of Major and received a Distinguished Service Citation. Following his discharge, he resumed his business career as a cost accountant and comptroller with Mohawk Carpet Mills in Amsterdam, New York.

On December 22, 1950, Maurice and his wife Wilma Jean were killed in an automobile accident near Sharon, CT. Son Richard graduated from Crosby High School, became a letterwinner with the UND Sioux Football Team, and was a founding member of Delta Upsilon Fraternity at UND. Richard graduated from UND in 1964, and now has an accounting practice near San Francisco. Richard, wife Lynn, and children Marna and Reed, attended the induction ceremonies.

Maurice's brother, Wilbur Gehrke

'39, also attended the ceremonies. He noted that a Crosby High School instructor, Burton Boyd, gave Maurice \$75 to finance his entrance to the University, and the rest he earned himself. That investment in 1931 proved to be excellent. Maurice was the first of twelve Gehrkes and immediate family to attend the University of North Dakota.

DELTS TALKING ABOUT ALCOHOL

On November 4, the pledges were taught the "Delts Talking About Alcohol" program. All of the pledges who attended received insight as to the problems and hinderances of alcohol consumption. After the program it was noted that several of the pledges who were formerly heavy drinkers, were not following the guidelines in the program.

There are several unique features contained in the "Delts Talking About Alcohol" program. This year four new instructors spent a weekend in Wisconsin to be trained on how to teach this program. The new instructors are Mark Casey, Bill Dolny, Reed Endersbe, and Mike Gillen. The program has three distinct sections that brighten the students through a series of mental progressions to arrive at a common goal. The program has been proven to be effective where it has been implemented. The program gives the students exact numbers and facts as to influence their drinking choices. It does not set out to control drinking choices, but merely to help give guidance.

The active chapter of Delta Xi feels that this program is so important, that they have made it a mandatory requirement for activation. Every active member in the house has been through this program. We can say positively that it has helped many of the members who were borderline alcoholics.

VP GORDON HENRY COMMENTS

Congratulations on the development and implementation of your new alcohol policy for Delta Tau Delta. I've had the opportunity to review the policy and I find it to be a breath of fresh air and a very courageous move for the men of Delta Tau Delta. I know that whenever a chapter takes the courageous moves you have taken, you will receive flack from other chapters, from some of the sororities, from friends, and maybe even from some members within the house—but I want you to know that it is the kind of courage that will be necessary for the survival of the Greek system as we move in to the 90's. I am very proud that you have made the decision to take a leadership role at UND.

Fraternities have the opportunity to provide much leadership on our campus. It is when they show courage such as the Delts' have shown, that it becomes evident that their leadership can be real and have an everlasting impact. We are now in an era of

University-fraternal relationships where chapters must deal with the risk that is involved in not being responsible. It is great to know that Delta Tau Delta has taken a step towards being more responsible.

I have many opportunities throughout the state and the nation to visit with alums from all chapters at UND. You can be assured that I will speak publicly and loudly about the courageous leadership which Delta Tau Delta has taken at the University. Many will know that your chapter is a leader in a very important area at our University.

Thanks for your efforts, your commitment, and your leadership! Delta Tau Delta has a strong tradition at UND and you have just helped to assure that tradition will continue to grow and develop at the University of North Dakota. Have a super year!

Delta Tau Delta Educational Foundation

Fraternity history was made in 1977 when the North Dakota Delt alumni successfully applied for tax-exempt status as a 501(c)3 educational foundation. No IRS regional office in the nation had previously approved of an educational foundation for the benefit of a fraternal organization. This national movement started on the UND campus, and the Deltas were the leaders in this innovative approach to encourage alumni involvement to enhance and support the continuing development of Delta Tau Delta and to assist promising students to develop their talents and potential for intellectual, social and cultural growth. It was four years later in 1981 when the National Office formed an educational foundation, which began operation in 1982.

Not only were scholarships approved, but leadership programming, operational support and chapter housing. Our alumni were successful in their arguments that a fraternal experience 1) is more educational than social, 2) benefits college students as an important adjunct to classroom education, 3) is the only effective laboratory on campus for leadership training, 4) provides academic support as an integral chapter program, and 5) provides student housing comparable to dormitory housing. Today, most of the 16 fraternities at UND have an educational foundation, and over \$3 million has been raised to support and enhance local chapters and their members.

Bruce Gjovig '74 has been our primary leader in this development and he has helped not only our chapter, but many chapters launch their educational foundations. Other leaders who were instrumental include George Allen '36, Merlin Dewing '56, Ordean Dahl '34, Harold Bangert '28 (deceased) and Kent McGregor '69. Twenty North Dakota alumni serve on the board of directors, serving as trustees, fund raisers, and program officers. Their goal is to assist, support, encourage and enhance the undergraduate Delt experience. We have a stronger Fraternity nationally because Delta Xi Chapter is stronger.

Since the educational foundation was launched thirteen years ago,

\$670,000 has been raised in cash contributions, pledges and deferred gifts. The goal is a \$1 million endowment. In the area of academic scholarships and achievement awards alone, over \$75,000 was awarded to undergraduate members. IBM computers were purchased for the chapter before the National had such a program. \$30,000 has been invested in leadership programming such as underwriting the costs of members to attend Karneas or conferences. Delta Xi is usually in the top

two chapters for attendance at any event, including 17 at the last Karnea. Last academic year, \$24,000 was granted to the chapter and members, which we believe is the most annual support given to any chapter by their alumni in the nation . . . not only in Delt, but in any fraternity.

Our Delta Tau Delta Educational Foundation has provided a great opportunity for alumni and parents to invest in and support the learning experience of Delta Tau Delta.

PAVING FUND DRIVE TO BE LAUNCHED

Dear Delt Alumni,

At the Homecoming Delt House Corporation and Educational Foundation board meetings the condition of the chapter house and parking lot were discussed.

The chapter has made great progress with a very successful rush with many great pledges and members.

The chapter house has just been recarpeted and looks terrific. This was much needed because of all the dirt and mud which had been tracked in since the house was completed in 1979. Some new furniture has also been purchased.

In the past the alley and parking lot have become extremely muddy and this has inevitably been tracked in to the chapter house. With the new carpet it is time to try to get the lot and alley paved.


It was decided that we need to launch a fund drive to pave the parking lot and alley. The cost for the lot immediately behind the house, the alley, and the lot across the alley is about \$59,000. The plan is to do this in two phases; doing first, the house parking lot and alley, and later the across the alley lot. The cost of the first phase is about \$23,000 and the second phase \$36,000.

Several Delt Alumni have made contributions toward this project but much more is needed. If you need the tax deduction you can contribute to the



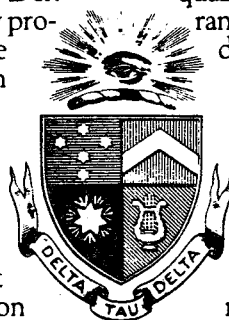
Of course, actions speak louder than words, and few fraternity academic programs are as comprehensive as ours. We publish two newsletters, conduct conference sessions on education

We develop and follow a master plan for each chapter to ensure appropriate recognition for high achievers, assistance and support for low achievers, and special rewards for top scholars.

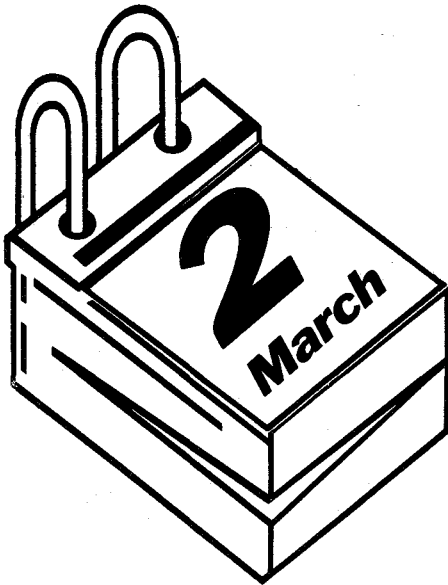
