On February 1, at the Northern Regional Conference in Madison, Wisconsin, Delta Xi Chapter was awarded its second Court of Honor in the chapter's history. The first of which was received in 1986. The Court of Honor is the second-highest accolade an undergraduate chapter of Delta Tau Delta can obtain, given to the second tier of chapters, or the top 20 of our 124 chapters. The highest being the Hugh Shield Award for the top ten chapters nationwide which we hope to achieve in the near future.

We were very proud to receive this award which was a result of hard work by our undergraduate chapter along with dedicated alumni support. The award is a reflection of the spring and fall semesters of 1991. It is based on campus and city involvement, scholarship, and overall achievement in the opinion of the national chapter. The entire undergraduate chapter would like to extend a thank you to all alumni who helped make this award possible.

Looking Ahead to Karnea 1992

Sigma Phi Epsilon to Colonize

Interfraternity Council voted to accept a bid to colonize from Sigma Phi Epsilon Fraternity for October, 1992. This will bring the total number of fraternities on campus to 14, with Theta Chi Fraternity expecting to recolonize in two more years for a total of fifteen. Theta Chi went off campus two years ago because of problems with their chapter. much like Beta Theta Pi did in the late 1970s.

Sigma Phi Epsilon is the second largest national fraternity with 265 chapters nationwide boasting more than 17,000 undergraduate members and 185,000 alumni. They stress a four-year education program for their members towards what they call the "Balanced Man." They want their members to be leaders, scholars, athletes, and gentlemen.

The "Sig Eps" were founded in 1901 at Richmond, Virginia. They have a chapter at the University of Minnesota, University of Montana, three in Wisconsin (Lawrence, Marquette, and the University of Wisconsin) and four in Iowa. Curt Carlson of Carlson Companies of Minneapolis is an alumnus, as well as the current CEOs of Merrill Lynch, Chevron, Good Year, Ford, and General Motors. They have a traveling staff of ten to visit their chapters.

O'Brien Elected Chief Justice

Once again, Delta Tau Delta will have a voice on the IFC executive council. On February 10, 1992, Mike O'Brien was elected Chief Justice on IFC's J-Board. He is eager to share his ideas to help better the Greek System. Mike will head the ten member IFC Judicial Board committee, which has been formed to enforce the by-laws of IFC. This position is not only a big responsibility, but one of influence, as Mike will have a "say" on executive matters.

Delta Xi has had more presidents of IFC in the last decade than any other fraternity — four! They were Jack Muhs '87, T.J. Foley '87, Ron Nelson '89 and Jon Furman '92.

1991 Successful Year for the Foundation

Thanks to you our generous alumni, 1991 was a successful year for the Delta Tau Delta Education Foundation. This year brought \$82,000.00 in new contributions. Of this amount \$9,000.00 was raised from our annual sustaining drive. This past year, sufficient funds were raised to pave the parking lot behind the house and the alley. A new computer was purchased and the old ritual robes from the 1930s were retired and new ones were purchased.


Our proposed budget for 1992 is \$31,000.00. Last year we had an income from our investments of approximately \$18,000.00. With interest rates going continually lower, it is necessary that we have increased donations in order to continue the programs already started. It is important that we not have to dip into our investments and use only the interest earned from our accounts. Therefore, I urge each of you to be

generous in 1992.

The Foundation Board met at the residence of Brother George Allen in Edina, Minnesota on January 18, 1992. There were ten members of the Board present along with special guest Steve Hockett, Divisional Vice President. The purpose of this meeting was to have a general discussion involving the financial condition of the Foundation. In addition, plans for the development of the Leadership Academy was also discussed. Bob Muhs, as chairman of the leadership committee, will be visiting the University campus within the next few weeks and more detailed plans for the establishment of the academy will be presented at our March 28th meeting. The March 28th meeting will be held in the Chapter house in Grand Forks at 1 p.m. in conjunction with Parent's Alumni Days. There will be a summer retreat at Merlin Dewing's cabin at Brainard, Minnesota during the summer and at that time the plans for the Leadership Academy will be

North Dakota Tuition highest in 9-state region

A recent report from the North Dakota Board of Higher Education indicated that tuition at UND and NDSU is the highest in the nine-state region. Tuition has doubled in the last seven years, and what used to be among the lowest tuition rates is now the highest. The tuition increases skyrocketed in the 1980s due to revenue shortfalls in the Legislature. In the 1970s, students paid about 15% of their college costs, today it is about 35%. North Dakota ranks 25th nationally in tuition charges, compared to 34th in 1987-88.

Tuition hikes in recent years are starting to price many students out of the market for higher education, at the same time that federal financial assistance is drying up. Chancellor Douglas Treadway said the situation is getting critical for many students, and every attempt is needed to be made to hold tuition where it was, and find more financial aid.
