## Ellinger Chosen for Pilot Intern Program

In an effort to further exposure and test a means of implementation, the new Fraternity has teamed with the Prevention Research of Institute Lexington, KY (the program authors) to offer a semester-long student internship. Barry A. Ellinger, a junior aviation major from the Delta Xi Chapter at the University of North Dakota, has been hired to serve in the inaugural post.

Barry was chosen for his knowledge of the Fraternity, both at the local and levels. and for his International outstanding performance as a Delts Talking About Alcohol instructor at his own chapter. He has helped make Delta Xi Chapter one of the most consistent advocates of this program. Barry also served as a member of the Fraternity's a sixteen Undergraduate Council. member body that works in conjunction with the Arch Chapter. Barry worked in conjuction with various Delt alumni to provide on-site teaching of the program in a number of chapters, primarily in the Eastern Division. Gamma Sigma Chapter at the University of Pittsburgh served as Barry's home and host during his semester away from North Dakota.

### **First Kramer Post-Graduate Scholarship Awarded**

Steve Mattson '93 is the first recipient of the Kramer Post-Graduate Scholarship. Steve Kramer '68 of Springfield, Oregon established the scholarship last spring to encourage and assist Delts to pursue post-graduate education at the University of North Dakota. The recipient receives \$1,000 per semester for the term of their graduate studies. Financial need is criteria for the scholarship selection. In establishing the fund, Kramer noted that he was able to get through law school by working and loans, but with the escalating costs of education, that is nearly impossible today.

Steve Mattson is attending the UND Law School, after taking graduate courses in history last spring. Mattson is a graduate of Central High School in Grand Forks, and grew up in a military family. Steve lived in seven different states and attended three separate high schools. He served as social chairman and house & grounds chairman for the chapter, and was the recipient of scholarships for academic performance.

Steve Kramer '68, '73 serves as a Federal Administrative Law Judge with the Social Security Administration. He has lived in Springfield, Oregon since 1986. Steve visited the chapter last March for the 75th year celebration meeting with chapter members and alumni.

# Erickson Aviation Scholarship

Since March, 1994 when the Chad Erickson Aviation Scholarship was have thirty people established. contributed \$7,600 in cash and pledged gifts. This is a tremendous response from Delt alumni, family and friends to honor Chad Erickson's life and set up an outstanding endowment to benefit aviation students who are Delts. Gifts to the fund have been received from Chad's mother, Jill Erickson, his fiance, Teri Dimond, and family friends.

A five-member committee is contacting Delts who graduated from UND between 1986 to 1994. Members of the committee are Bob Williams '89, Robb Ramsay '90, Jay Wolf '90, Bob Lieser '87, and Fred They encourage all Delts Sontag '92. who knew Chad to contribute to the endowment fund, and participate in 1995 when the first Chad March. Erickson Scholarship will be awarded to a deserving aviation major. Selection will be made by a committee of at least three aviation alumni acting as a scholarship the Educational committee for Foundation.

Brother Erickson '90, died on December serving as First Officer on 1.1993. Northwest Airlink Flight 5719 that crashed near the Hibbing, Minnesota Several publications including airport. the Wall Street Journal reported that the National Transportation Safety Board believes the Express One Captain was in an angry mental state, and pilot error was the main cause of the crash. The Captain, Marvin Falitz, had a history of intimidation, deliberately handling the controls roughly, and he distracted his copilot, Chad, over the runway lights when the altitude should have been monitored. Eighteen people died in the accident.

# Marking our 75th Year

To commemorate our chapter's 75 years on the University of North Dakota campus, the board of directors set a goal to raise \$75,000 for:

1.) Academic Scholarships

2.) The chapter leadership academy

3.) A short-term emergency loan fund

As of September 15th, 55 donors have contributed \$28,500 in cash and \$31,000 in pledges, for a total of \$59,500. 80% of our goal is realized. That is a tremendous alumni response. Additional participation will ensure the next \$15,000 will be raised to meet our goal.

North Dakota Delts have a national reputation for generosity, not only among Delts but among all 65 national fraternities. Our educational foundation is recognized in the fraternity world for outstanding fund raising success, program accomplishments, and for the tremendous loyalty and generosity of North Dakota Delt alumni. Congratulations! Please take a moment to celebrate your national standing. You are a member of a unique and fine organization.

There is still work to do, and needs to be met. Endowment earnings are down from a few years ago, scholarship demand is up, and students are struggling financially. The Chad Erickson Aviation and the George Allen Improvement Scholarships need to be fully endowed. New scholarships and awards are needed to encourage academic diversity in the chapter and reward achievement. Our leadership academy shows great promise, and needs to be fully endowed. We are undertaking a strong initiative on career mentoring, bringing alumni and students together in career fields. There are expenses to cover. A strong partnership between alumni and undergraduates offers great benefits to students, alumni and society. It is worthy of your investment.

This spring, North Dakota Delts were named a "top ten" chapter in the nation by receiving the prestigious Hugh Shields Award. Earlier Delt was named the top fraternity on the UND campus. Four times since 1985 our chapter was named to the Court of Honor -- a top twenty chapter. Thank you for investing in the Delt success story: it is a great dividend. We started our lives on foundations and in institutions created by others. In the farm vernacular, we should leave the wood pile a little higher than when we found it. As Delt Chester Fritz often said, we should build a stronger foundation from which others can build, so they can raise their heads above the crowd. Your time and contributions make a difference. ## Charitable Remainder Trusts

If leaving part of your estate to charity (such as the Delta Tau Delta Educational Foundation of North Dakota) is a priority, a Charitable Remainder Trust (CRT) is an excellent vehicle to accomplish this objective. A CRT provides for tax free growth of assets, while providing income to the donor and spouse. In establishing a CRT, a donor may contribute highly appreciated assets without incurring any capital gains tax and at the same time, receive a substantial current charitable deduction on his income tax return.

Once established, the CRT is a tax-exempt trust and pays no income taxes on income. Any dividends and interest produced by the trust are distributed to the donor and are taxed as ordinary income to the donor. Upon the death of the donor, the assets remaining in the CRT are distributed to the designated charities.

Since the trust pays no tax, the tax savings remain part of the earnings assets, benefiting the donor and charities. Investments within the trust can be structured to emphasize growth og the trust or income to the donor.

## Skalicky Establishes Scholarship

Norman Skalicky '55 of St. Cloud, Minnesota has established a new scholarship fund to encourage and assist outstanding students enrolled at the University of North Dakota to join Delta Tau Delta Fraternity. Each new member who pledges the Fraternity will be eligible for a \$100 scholarship in their pledge semester if they meet the scholarship's criteria.

The scholarship is being established to recruit outstanding new members. For both high school and college students with an established college GPA, the selection criteria includes a GPA of at least 3.00 along with leadership criteria would include such activities as Eagle Scouts, Honor Society, language clubs, science clubs, etc. In this way they have demonstrated potential for leadership and teamwork, which will maximize the likelihood the new member will be active in the Fraternity.

For the Fall 1994 Pledge Class, the Skalicky Scholarships were utilized as a rush tool to attract academically superior students who also have strong potential for leadership. Nearly every new pledge is eligible for the Skalicky New Member Scholarship attesting to its benefits in recruiting top members. Norm made an initial contribution of \$2,000 to the new fund, and it will be used in its entirety.

Since 1965, Norm has been president and chairman of the board of Stearns County Bank, a chain of Banks in central Minnesota based out of Albany, Minnesota. He also serves as president of Stearns Financial, a national leasing company operated out of Albany. 
