

# Delt Education Foundation: 1978-1998

The Delta Tau Delta Educational Foundation has by all measures been very successful since its historic launch twenty years ago. The North Dakota Delts negotiated with the IRS for two years to establish the first chapter educational foundation of its kind in the nation, an honor shared with Phi Delta Theta. Thus, UND unknowingly became the home of the national fraternal educational foundation movement which has spread to campuses from coast to coast providing much needed funds to renovate tired chapter houses

and offer incentives and programs like scholarships, awards, and leadership programs. Most importantly, educational foundations provide an innovative vehicle for more alumni participation with undergraduates of potential and promise. This novel experiment is changing the way fraternities operate, helping them focus on their historical mission of fellowship, education. community service and leadership.

# <u>The Founders</u>

Our founding members were Ordean Dahl '34 of Litchville and now Olympia, WA; George Allen'36 of Edina (dec.);Harold Bangert '28 of Fargo and San Francisco (dec.); Scotty Cranna '30 of Devils Lake; Bruce Listoe'55 of Ashby, MN (dec.); Bruce Gjovig '74 of Grand Forks; Merlin Dewing '56 of Minneapolis; Neil Fleming '65 of Cavalier; Kenton McGregor '69 of Grand Forks; and Guy Rzeszutko '74 of Grand Forks and Pocatello, ID. The founding members were seeking a tax-deductible vehicle to raise funds for a new chapter house in the days of raging inflation and high construction costs. The

## House **Corporation**

"The progress made on renovating the chapter house since the flood in April of 1997 is truly amazing. The Delts are true leaders in this effort and overall on campus, and were the first fraternity to complete the renovation effort. The chapter members be are to congratulated for their efforts. This was the general sentiment at the House Corporation Board of Directors Meeting on March 28, 1998. There was a great turnout by Chapter Officers from Chapter President Jim Thompson on down.



of Bruce Gjovig, the Alumni The total for Chapter House repairs and renovations has reached \$328,000. The House Corporation requested an additional \$85,000 from the Educational Foundation to pav for repairs and improvements over and about what insurance covered. About half will be in the form of a grant and half will be borrowed and will be a loan to be repaid to the Educational Foundation. Norm Skalicky, '55, a significant donation towards the recovery.

> In recognition of his continued support and leadership. we voted unanimously to name the library the Skalicky Library. The House Corporation thanked Norm at the Library dedication on March 28th this spring.

> The house will remain open this summer with rent set at \$125/mo per member with the Chapter members being responsible for utilities. The annual rent was not changed and will remain at \$4500 per month for eight months with an additional \$100 per member per year to be paid toward our liability insurance.

> Again, thanks to all those contributing toward making the Chapter House the best on the University of North Dakota campus.

immediate problem to solve was building a new Shelter before the old one collapsed, burned down, or was removed by the widening of Columbia Road. It was do or die.

#### **Shelter Built**

Through foresight, the House Corporation invested in neighboring properties in 1967 and 1975, which were sold in 1977 to buy the property next door from UND, the current Shelter site. Still, \$80,000 of alumni funds were needed to start construction. The initial response from alumni was slow, steady but growing. Fulfilling a 25 year goal, the new \$430,00 Shelter was built in 1979, and goals were set to furnish the library, purchase the lot across the alley for parking and expansion and to pay off the mortgage at the savings and loan so no outside force could affect our long-term housing future. Our initial goals were met, as new goals were being formulated. Our dreams grew as success grew, and our initial investment was showing favorable returns.

# **Emphasis**

Soon the attention of the board was shifted to a new emphasis, building an endowment to assist the Fraternity in its educational mission and to serve as an insurance policy against financial hard times. Our minutes and records from 1979 offer hope of endowments and scholarships. We wanted to be among the first to have computers for our members, which we did. We saw the need to provide academic scholarships and recognition awards for individual and group excellence, and to provide educational programming, and assistance to attend conferences and Karneas. The goal was to become the best Fraternity at UND, and the best chapter of Delta Tau Delta through educational development and support of excellence.

#### **Recognized Leaders**

In 1979 we offered just two academic scholarships (George Allen Improvement Scholarships and the Carlyle **Onsrud Pledge Scholarship**) and two recognition awards



(Edward X.Hallenberg Red Key Award and the Gjovig Grand Old Delt Award). By 1981, under the leadership of the Educational Foundation president Merlin Dewing '56, the scholarship program framework and goals were set with a matrix of academic scholarships, recognition awards and educational programs. The first endowment goal for scholarships was a modest \$40,000. By 1983 that endowment goal grew to \$300,000. Within the first years of organizing, North Dakota Delts drew national attention for its fund raising successes and growing its academic. leadership, and career mentoring programs. By 1987, the North Dakota Delts were the recognized leaders in the fraternity world with its educational foundation, a leadership position we enjoy a decade later because of continued outstanding alumni support and participation. Today over \$1.8 million in cash, pledged and deferred giving has



been invested, a phenomenal success story. This is a record our founders would not have believed possible. This is likely the highest giving record per alumni in the fraternity world among all 6000 chapters in 65 fraternities nationwide. WOW. We don't have the most alumni, or the richest alumni, but we do have the most generous alumni.

#### <u>Return on</u> Investment

Alumni investment provided the financial support, guidance, and volunteer effort necessary for our individual members and the chapter to excel. Many Delt alumni have realized great career success and have been leaders in their profession, associations, and communities; in no small part because of the Delt influence and network. Our chapter has been recognized many times as the best fraternity on campus, and among the top ten chapters nationwide in Delta Tau Delta. This is a very measurable return on your investment of which all investors and participants can be proud. Our stock in Delt is at historic highs.

The return on our investment is both tangible and

intangible. We notice recognition awards and career successes: and on occasion note valuable lessons, expertise, bortherhood, and values. Our favorable influence on hundreds of young Delts is not easy to measure. But we can say with confidence that providing an extraordinary Delt experience will make a great difference as young men start their professional and family lives. Investing in people is a longterm deal as one never knows if the influence demonstrates itself early or late. Many do not recognize the influence Delt has on their ability to be a leader, team player; or be a person of honor, loyalty and integrity. We often see the influence and benefits on others before we see it in ourselves. Mirrors give distorted reflections and memories fade like old photos. Some alumni donate in appreciation of what they received, many because they want to invest in future leaders.

#### <u>The Future</u>

Being the lead dog means never getting to slow down or the followers will pass you by. There is much we can do to enhance our educational,



This novel experiment continues to show great promise, and further innovations and successes are clearly at hand. Unfortunately the Grand Forks crew is tired and worn after a year of recovery efforts after the historic flood of 1997. This provides an opportunity for others to participate and lead. Ralph worked as a teacher, served in the Army Postal Corp during World War II, and became postmaster in Cass Lake after the war. He retired in the mid-1970's and spent winters at Weslaco, Texas and summers at Cass Lake. He is survived by two sisters, Leila Creech, M.D. of Cass Lake and Erma Welsh of Bethesda, MD.

# **Recruitment**


