## Kennedy Memorial Scholarship

A \$1,000 memorial scholarship for deserving members of Delta Tau Delta has been contributed by Donald J. Kennedy and his two brothers Bob and Jim. Their contribution is in memory of their father James M. Kennedy '33 and their uncle Angus K. Kennedy, Jr. '35. Previously Don Kennedy had contributed for the same purpose in memory of his uncle Douglas "Pete" Kennedy '37.

The memorial scholarship grant has been established to provide financial assistance to deserving members of Delta Tau Delta who would not be able to continue their university education without some financial assistance. This is a very timely contribution as current economic conditions find young Delts with parents suffering from unemployment, summer jobs difficult to find, and part-time work not always available or enough to pay the education and living costs. After a recommendation has been made by the Treasurer and President of the Chapter, the facts and need are reviewed by three directors of the Delta Tau Delta Educational Foundation, and a determination will be made on the award. We are grateful for this generous contribution, and feel it is a fine way in which to remember the three Kennedy brothers who were members of our Fraternity.

Ferguson Stewart '37, '39 of Santa Monica, CA has also contributed towards this Kennedy Memorial Scholarship. He is a friend of the Kennedy brothers who made this gift possible. Don Kennedy of Camarillo, CA is President of Nightvision, Inc., an entrepreneural firm in high technology.

## Robert C. Ray Scholarships

Robert C. Ray, MD, BX '28, '29 has established a scholarship for pre-med or science majors who are outstanding and deserving members of Delta Tau Delta Fraternity. This scholarship is endowed with an initial gift of \$4,500. The principle of the gift shall be held in perpetuity, and only the income earned will be awarded.

Dr. Ray wants to recognize worthy members of the Fraternity who are of good moral character, have a record of academic achievement, exhibit leadership, and show potential for a successful career. Hometowns and financial need may be given consideration as well. Final determination for the scholarship may be made by Directors of the Delta Tau Delta Educational Foundation of North Dakota.

Dr. Ray retired from the Medical Corps of the US Navy in 1961 after 22 years of service. Thereafter, he served on the faculty of San Diego State College. and is now emeritus status. Dr. Ray is a Fellow of the American College of Surgeons, and a Fellow of the American Society of Abdominal Surgeons.

Both of Dr. Ray's parents attended UND as well, Robert H. Ray, MD '97 and Emma (Robinson) Ray '98. His dad practiced medicine in Garrison until 1948. Dr. Ray and his wife Meryl (Hudson) '28 live at 3020 Dumas Street, San Diego, CA 92106. They had one son John.
