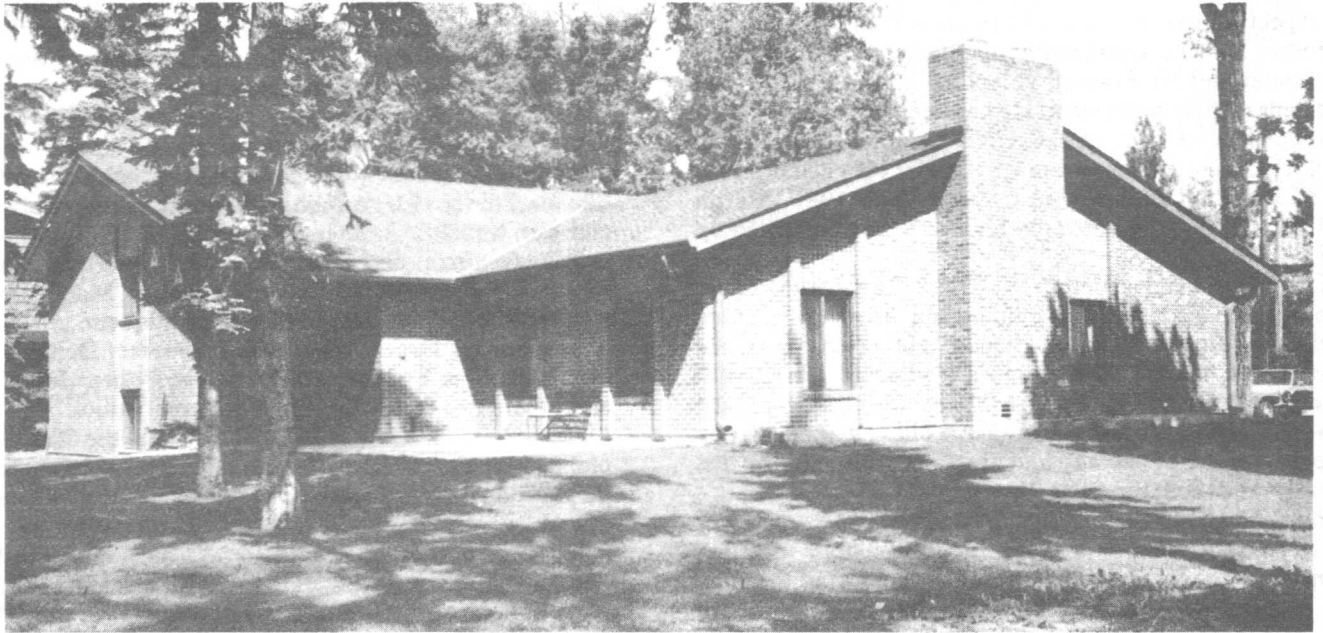

DEWING RECEIVES NATIONAL ALUMNI ACHIEVEMENT AWARD

Merlin E. Dewing '56, '58 received the Alumni Achievement Award of Delta Tau Delta Fraternity at the 77th Karnea held at Columbus, Ohio on August 8-11, 1984. Brother Dewing was recognized by the Fraternity for his exemplary professional achievement, and outstanding community leadership.

In his capacity as Managing Partner of the Twin Cities office of Peat, Marwick, Mitchell & Co., he is responsible for over 250 staff, and for the direction, development and overall administration of the Twin Cities practice. His special talents have been called upon by his profession as he serves on PMM & Company's Long Range Planning Committee and has been elected to serve as President of the Minnesota Society of CPAs and as a member of the Governing Council of the American Institute of Certified Public Accountants. Recently he was elected to the International Board of Directors of PMM & Company. He is a well recognized leader in his profession.

Brother Dewing has been recognized as a leader in one of the major metropolitan cities of the nation, serving as President of many civic, service and community organizations. He is past-president of the Greater Minneapolis Chamber of Commerce, Director on the Bush Foundation,

In 1983, Merlin received the Sioux Award, the highest honor presented by UND.

He often visits the chapter, and has even sponsored a leadership retreat with alumni and undergraduates at his lake cabin. This Good Delt answers every call for assistance. DELT PARKING LOT

The Delta Tau Delta Educational Foundation invested in the lot owned by the City of Grand Forks that is just across the alley from the Chapter House to the north. The House Corporation had been leasing that lot for three years to park about twenty cars. The bid of \$10,360 was accepted on April 1, even though the city assessor placed the value of \$19,500 on the 8,654 square foot piece of property. About \$2,000 in improvement are needed on the property such as additional graveling, drainage and maintenance on the two-car garage on the property.

The Educational Foundation wanted to make this investment as it will meet the parking needs of the chapter for the future, and if the chapter house is ever added onto, that space is crucial for that expansion. Buying land in the University area is also considered to be a good long-term investment.

A Fund drive is underway to raise the money for the purchase and improvements. So far \$5,000 has been raised from the efforts of Merlin Dewing '56, '58 who is contacting a handful of alumni to contribute to the \$12,500 project. Merlin has indicated that should the response bring in more funds than is required, the additional funds would be applied to the \$300,000 endowment campaign. Those funds will carry the mortgage on the Chapter House and the income provides scholarships and funding for worthy programs for the undergraduate Delts. We are hoping for a favorable response, and anyone wishing to participate is encouraged to do so.

PAINTERS WITH A MISSION

UND students help with paint job

Some of the peeling walls in the Grand Forks Mission got a lift Saturday when members of the Delta Tau Delta fraternity at the University of North Dakota took time out from studies and parties to paint.

About 30 of the fraternity's 45 members helped rejuvenate the hallway and recreation room on the main floor of the mission, 420 Division Ave.

"Everybody seems to feel pretty good about doing this," said Ron Nelson, a fraternity member who helped organize the project. "They weren't too excited about coming over here, but once we came, things started steamrolling."

Like most of the students, Nelson had never been inside the mission. He said the experience was beneficial to the residents and the fraternity.

"In fact, we met one resident whose mother had cooked for our fraternity six years ago," he said.

A mother of one of the pledge members suggested the fraternity consider the mission as a service project. Calvary Lutheran Church donated the paint.

"We started with 10 gallons of paint and thought that would do it," Nelson said. By the end of the afternoon, they had emptied 17 gallons.

The fraternity's 15 pledges — students who want to join the group — took up paint brushes at 6 a.m. They had no choice. Other members stopped by at their convenience.

Six or seven women from Kappa Alpha Theta, a campus sorority, pitched in at the fraternity's suggestion. "We figured getting some girls over here would liven things up," Nelson said.

Delta Tau Delta plans to issue a challenge to other campus fraternities to match their work at the mission. Several students said they would be interested in returning to the mission to do more work.

The Rev. Dwain Steinkuehler, director of the mission, recently appealed to area churches for help remodeling the mission. Volunteers from Calvary Lutheran painted a room, and First Presbyterian Church members have promised to paint the hallways on the building's top two floors.

Next week, the mission will appeal to the public through television commercials. The 30-second spots will explain the mission's role in the community. "It's basically just a plea to the community to come and work with us," said Cass Johnson, the mission's assistant director.

Stella Lutz, a mission resident, took a good look around the recreation room when the students were nearly finished. The dirty green walls had been buried by creamy yellow paint, and the worn green carpet looked perkier with a shampoo and vacuum.

"It's worth it," she said, smiling.
